There is a whole ream of legislation covering the blocking of a dropped kerb under section 86 of the Traffic Management Act 2004 covering this and it does allow some exceptions, such as work people carrying out certain work, etc, but my advice is for people to either ask the work person to move or the Police will be called, or to call 101 when an obstruction occurs. I.e. when someone wants to use it to cross the road. We can then assess whether there is any lawful parking or not. Lyn did say that whilst the chain walkway is not rotten that it may not pass the ROSPA check as chains are now not acceptable anymore, so depending on the ROSPA report we may have to consider replacing this equipment.	
						There are three seats in the playing field area and only one is good enough to be kept (this is by the commentative stone) and just needs a strut to be replaced. The seat within the children's play area needs to be dumped and possibly replaced with a picnic type seat. The other seat adjacent to the play area needs to be replaced with say a substantial recycled plastic seat.  The perimeter hedging on the left of the playing field (from Mill Lane end ) is overgrown with blackberry bushes and needs to be considerably cut back, this is something that Lyn and Teressa are considering carrying out but again help from the village would be gratefully accepted. The right hand perimeter and stream area needs to be cleared with the use of a digger as again it is overgrown. The stream actually back fills when there is heavy rain to Mill Lane into Mr Bolt's garden so this needs work in the playing field area to rectify this problem.
