Who is responsible for contingency planning in the case of a serious incident on the A35 within a settlement? Not your run of the mill vehicle accident but something like a liquid gas tanker losing control down Chideock Hill, smashing into buildings and exploding, setting light to thatch, causing casualties etc.<br>2. Who grants permission of wide loads e.g. static caravans to come along the A35? What precautions must the haulier take and under what conditions will a road closure be made?<br>3. Hay lorries. If you look along the verges almost anywhere, including the A35 through Chideock, you will see straw. This is from the transportation of uncovered hay bales. The straw then clogs the gulleys. Also, the bales are loaded to a great height so that overhead cables are in danger of being caught - this happened last year in the centre of Chideock causing the electricity cables to come down and, obviously, a power cut. However, I do not know if there is any contingency planning on this matter and whether it would be dealt with by the relevant emergency service to deal with as and when it occurs and other agencies would be tasked with certain aspects of it. It is almost certain that each emergency service and likely and Council department like the Highways team, would have their own plans to deal with such emergencies.<br>Re matter 2, I would say the lead agency would be the Local Authority but with likely inputs from other agencies.<br>Re matter 3, I would suggest that any unsafe loads or incidents of loads being shed as you have mentioned, are reported to Police at the time. I am sure there are restrictions on certain vehicles being able to tow/carry certain weights and at certain heights and covering the possibility of loads being shed, but having never dealt with this personally, I can't specify what this is and who would deal. I have copied my Sergeant into this reply should he know and be able to provide an answer." |                               |

We understand the meeting has been called as a result of the correspondence sent by the Parish council earlier this year in regard to the WSP report and the A35.</p> <p>However having considered the matter further, we would request that the meeting at this stage does not include Andy Roberts and Emma Bazeley. The reason for this is not because we do not value their contribution but because we are clear that there is little further at their level that they can add to the discussion.</p> <p>Andy has fully clarified with the parish council the limitations of his authority and he is clear about the nature of the core business of HE, which is to deliver a throughput of traffic without any significant delay. We need to be clear that this is not a criticism of Andy or Emma, who have over time sought to communicate and work with the Parish council.</p> <p>But, and it is a big but, the Parish Council after many years understand that if any of the A35 matters are to be resolved in full for this village then such discussions need to take place with those strategic managers / ministers / councillors who are responsible for the delivery of the National and Strategic network. This includes those in Dorset who are responsible for the South West Gateway, the LEP, and now the Climate Change Agenda through the new Environment committee.</p> <p>Therefore the Parish Council would welcome a discussion at the meeting about who should be at the table in future. Clearly from our perspective we need to move above the operational managers and instead begin to talk to those strategic movers and budget holders who make the decisions about what happens in Chideock both now and in the future.</p> <p>The Parish Council hopes this makes sense and that you will agree to withdraw the invitation to Andy and Emma.,</p> |  |

I have been given your details as the person to speak to about placing signage on the land adjacent to Seaton Beach to inform dog owners that the beach has a restriction against dogs during the summer period (1st May – 30th Sept). I understand that you have some reluctance against placing too many signs in the area, and I would agree that this would make it untidy and cluttered if undertaken without careful consideration. In order for the Order (enclosed) to be enforced it is important that signage is clear and prominent for the public to read. The restriction was requested to be included in the Order by the land owners of the beach, and was agreed by Council, following a consultation process with the public in 2016/17. The Order became enforceable from the 1st October 2017. I am seeking your agreement to have 2 signs displayed on the land owned by Palmers Brewery. One 'end on', on the fencing opposite the toilets, and one perhaps on the car park attendance's hut, both to be visible on the approach to the beach for visitors and local residents to see, positioned either side of the stream. This should compliment the signage display boards recently provided which I was consulted upon. If you wish I am happy for them to be removed during the winter periods, when the exclusion restriction is no longer enforceable (1st Oct – 30th April). Chideock Parish Council have bought a number of signs to assist in informing the public which will also enable Officers to patrol the beach and the immediate area for all aspects of the Order, when they are present. They are happy to install the 2 discussed above, once your agreement has been given. Your co-operation and assistance in this matter would be very much appreciated." |          |
