Feasibility Study dated January 2019. The Parish Council acknowledges that this Study concluded with the recommendation of following only four of these options (Options 2 and 3 were either / or), however the Parish Council will, in addition to these four, endeavour to pursue all of the options identified where the Parish Council considers these to be feasible.

- b) Long-term measures including, but not limited to, a village bypass. The Parish Council acknowledges that the actual route (if any) will be determined by the Department for Transport and not by the Parish Council but the Parish Council will fully engage with any feasible proposal that removes through-traffic from the village.”
